We would appreciate any comments or suggestions you may have.

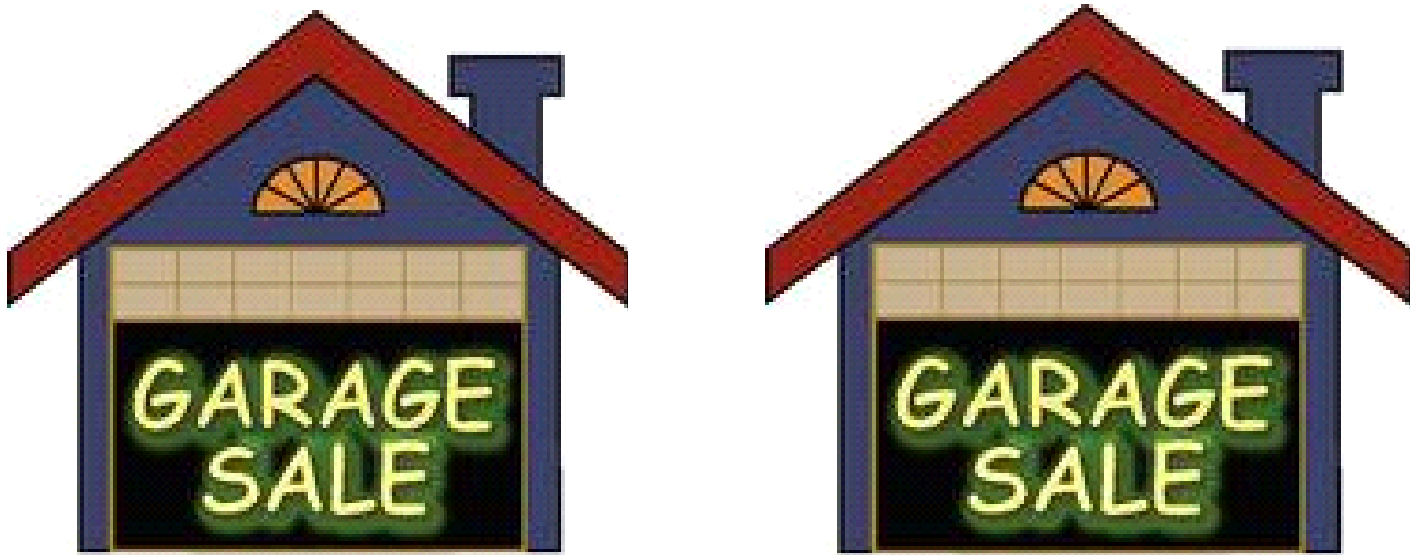

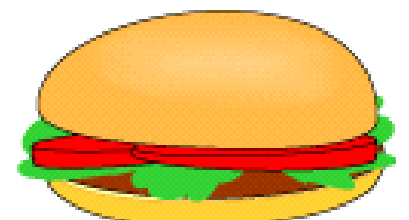
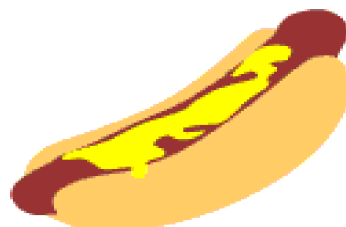
